

ORDER OF TAKING

329

We, THOMAS J. McEVoy (Chairman), JOHN F. COADY and JOSEPH A. GUTHRIE, being the duly elected Selectmen of the Town of North Andover, Essex County, Commonwealth of Massachusetts, and acting under the authority to us given by the inhabitants of said Town by their vote upon Article 50 of the Warrant for their 1975 Annual Adjourned Town Meeting, do hereby take in fee simple, absolute, in the name and behalf of said Town, by right of eminent domain, for the purposes set forth in said Article, to-wit: as a site for sanitary landfill, those parcels of real estate hereinafter described, in their present condition, including all trees thereon. And we further hereby make the monetary awards of damages hereinafter listed for the taking of said parcels to such persons as may be entitled thereto (hereinafter referred to as the "Supposed Claimants"), each of whom will forthwith be notified of this Order of Taking pursuant to the provisions of Section 7C of Chapter 79 of the General Laws of said Commonwealth. All of the parcels taken by virtue of this Order are shown upon that Plan of Land recorded at the Registry of Deeds for the Northern Registry District of said County as Desk Plan No. 7576, are designated thereon as Parcels numbered 2,3,4,6,7 and 8, and are hereinafter so designated.
